

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The District of Uttlesford (Reorganisation of Community Governance) Order 2022

Made - 28th January 2022

Coming into force in accordance with article 1

Uttlesford District Council ("the Council"), makes the following Order in exercise of the power conferred by section 86 of the 2007 Act.

Citation and commencement

1. This Order may be cited as the District of Uttlesford (Reorganisation of Community Governance) Order 2022 and comes into force on the day after the day on which it is made.
2. For the purposes of proceedings preliminary or relating to the elections of parish councillors for the parishes listed in Schedules 2 and 3, to be held on the ordinary day of election of councillors in 2023, this Order shall come into force on the day after which it is made.

Interpretation

In this Order –

"existing" means existing upon the date upon which this Order was made.

"maps" mean the maps marked "Maps referred to in the District of Uttlesford (Reorganisation of Parish Electoral Arrangements) Order 2022 and deposited in accordance with section 96(4) of the 2007 Act.

"ordinary date of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983, and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8 (c) of the Representation of the People Act 1983.

Effect of Order

1. Alteration of Parish Boundaries

The areas comprising the areas hatched in pink on the maps and specified in Column 1 of Schedule 1 shall cease to be part of the parishes specified in that area in Columns 2 and 3 of the Schedule and shall become part of the parishes specified in relation to that area in Columns 4 and 5 of that Schedule.

2. Renaming of a Parish

That the name of Elmdon and Wenden Lofts Parish Council be changed to Elmdon, Duddenhoe End and Wenden Lofts Parish Council.

3. Rearrangement of Wards and Distribution of Seats

Upon this Order coming into effect, that the wards and distribution of seats within Saffron Walden Town described in Schedule 2 shall be as described in that Schedule.

Any previous Orders determining the arrangement or wards and distribution of councillors within Saffron Walden are revoked insofar only as they relate to the wards listed in that schedule and not to any other.

4. Number of Councillors in Parishes.

Upon this Order coming into effect the number of councillors representing the parishes described in Schedule 3 shall be the number specified in that Schedule.

Any previous Orders determining the number of parish councillors allocated to those parishes described in Schedule 3 to this Order are revoked insofar only as they relate to the parishes listed in that Schedule and not to any other parishes.

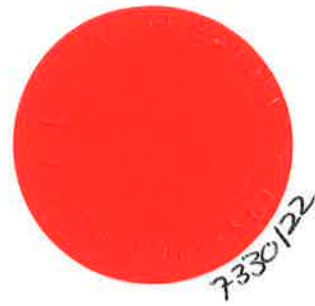
5. Electoral Register

The Electoral Registration Officer for the District shall make such arrangements of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

6. Order Date

1st April 2022 is the Order date for the purposes of the Local Government (Parishes and Councils) (England) Regulations 2008.

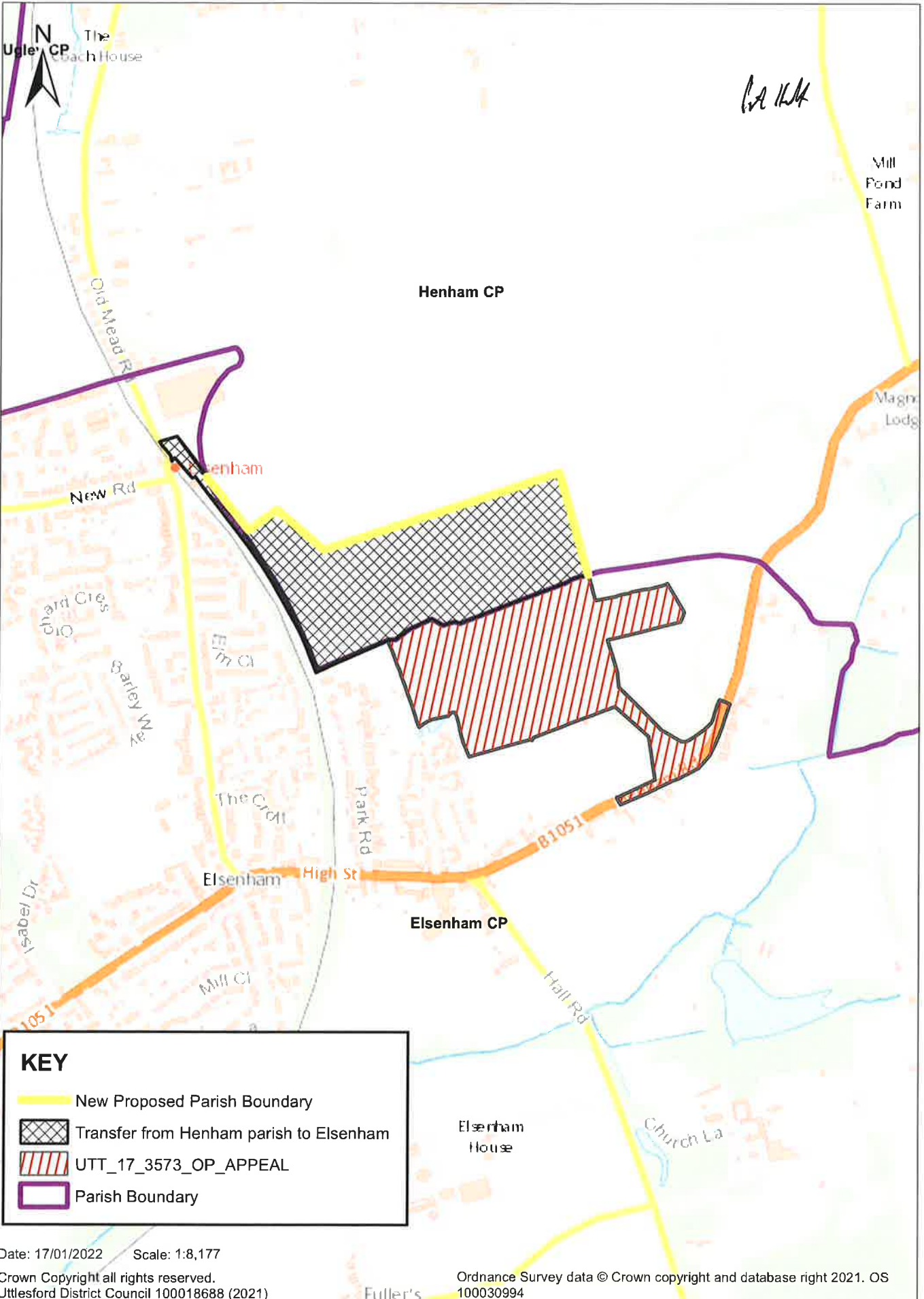

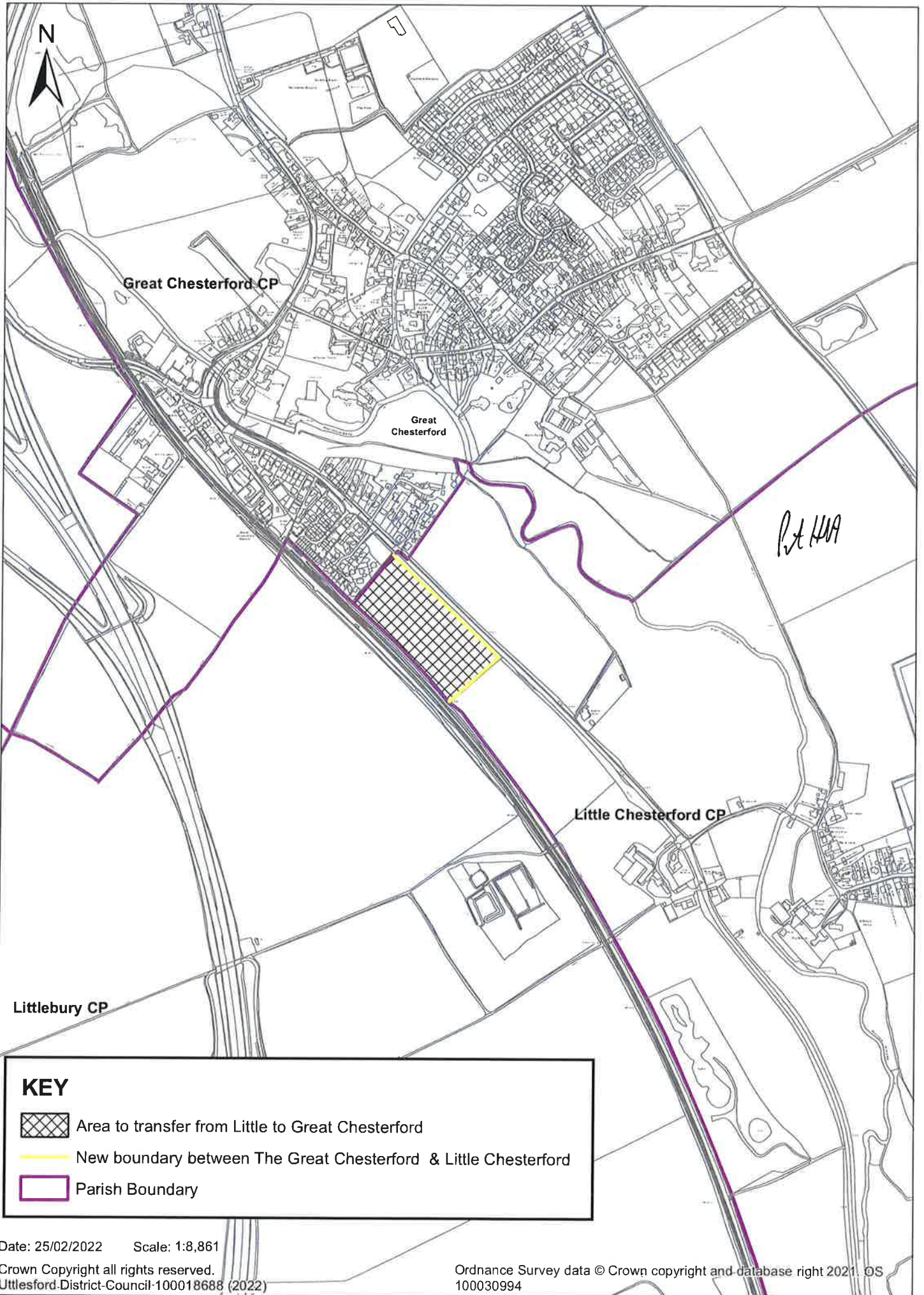
