Saffron Walden Town Council Child Protection and Vulnerable Adults Safeguarding

Our Safeguarding Policy

This policy applies to all staff, including senior Managers, paid staff, volunteers, sessional managers, agency staff, students, Town Councillors and anyone working on behalf of Saffron Walden Town Council

The purpose of this policy:

- To protect children, young people and vulnerable adults who receive Saffron Walden Town Council's services. This includes the children of adults who use our services.
- To provide staff and volunteers with the overarching principles that guide our approach to safeguarding and child / vulnerable adult protection

Saffron Walden Town Council believes that a child, young person or vulnerable adult should never experience abuse of any kind. We have a responsibility to promote the welfare of all children, young people and vulnerable adults and to keep them safe. We are committed to practice in a way that protects them.

Legal Framework

This policy has been drawn up on the basis of law and guidance that seeks to protect children, young people and vulnerable adults including:

- Special Education Needs and Disability (SEND) code of practice: 0 to 25 years Statutory guidance for organisations which work with and support children and young people who have special educational needs or disabilities; HM Government 2014
- Information sharing: Advice for practioners providing safeguarding services to children, young people, parents and carers; HM Government 2015
- Working together to safeguarding children: a guide to inter-agency working to safeguard and promote the welfare of children; HM Government 2015
- Polices held by Essex County Council with an overall responsibility for the safeguarding of children, young people and vulnerable adults in Essex

Definition of Adult Safeguarding

The statutory framework introduced under the Care Act applies to any person aged 18 or above who:

- Has needs for care and support (regardless of the level of need and whether or not the local authority is meeting any of those needs)
- Is experiencing, or is at risk of abuse or neglect, and
- As a result of those needs, is unable to protect themselves against the abuse or neglect or the risk of it.

Are there different types of abuse?

People can be abused in different ways. The different types of abuse that people may suffer are listed below:

- Physical abuse
- Domestic violence
- Sexual abuse
- Psychological / Emotional abuse
- Financial abuse
- Modern Slavery
- Neglect and acts of omission
- Discriminatory abuse
- Organisational abuse
- Self-neglect
- On line abuse such as trolling, grooming or the sending of inappropriate or offensive material or content

This policy should be read alongside our policies and procedures on:

We recognise that:

The welfare of the child is paramount, as enshrined in the Children Act 1989

The welfare of the vulnerable adult is paramount as defined in the Care Act 2014 Version 3 adopted April 2021

All children, young people and vulnerable adults regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have a right to equal protection from all types of harm or abuse

Some children, young people and vulnerable adults are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues

Working in partnership with children, young people, vulnerable adults, their parents, carers and other agencies is essential in promoting the welfare of all.

We will seek to keep children, young people and vulnerable adults safe by:

- Valuing them, listening to them and respecting them
- Ensuring that those delivering children's services on behalf of the Town Council have child protection and safeguarding policies through procedures and a code of conduct
- Providing effective management for staff and volunteers through supervision, support, training and quality assurance measures
- Recruiting staff and volunteers safely, ensuring all necessary checks are made
- Recording and storing information professionally and securely, and sharing information about safeguarding and good practice with children, young people, vulnerable adults, their families, staff and volunteers via leaflets, poster, one-to-one discussions
- Using our safeguarding procedures to share concerns and relevant information with agencies who need to know, and involving children, young people, vulnerable adults, parents and families and carers appropriately
- Using our procedures to manage any allegations against staff, volunteers and councillors appropriately
- Creating and maintaining an anti-bullying environment and ensuring that we have a policy and procedure to help us deal effectively with any bullying that does arise
- Ensuring that we have effective complaints and whistleblowing measures in place
- Ensuring that we provide a safe and physical environment for our children, young people, vulnerable adults. staff and volunteers, by applying health and safety measures in accordance with the law and regulatory guidance.
