Trustees

Details of Trustees are shown on page 1.

Financial Review

The accounts show a surplus of £4,180 (previous year surplus of £5,649). Receipts from all sources totalled £16,374 (previous year £10,849). Payments were £12,194 including depreciation of equipment (previous year £5,200). The more unusual patterns reflect the impact of the Coronavirus lockdowns on normal operations. This includes significantly increased cleaning costs as we undertook a deep clean before re-opening the Centre and purchased specialist sanitiser and protection items to ensure we could operate safely.

A grant received during the year enabled us to purchase a defibrillator, which provides an additional level of comfort for our vulnerable members.

Reserves

The General Reserve increased to £18,938 from £14,758, before including the Property Maintenance Reserve of £6,500 that was released during the year. This reflects the need to ensure that the reserves are used for the benefit of the members at a time when there are no anticipated building issues. The Accumulated Fund was £25,438 (previous year £21,258).

General

2021/22 was another unusual year. The Centre finally re-opened in September 2021 but then closed again at the end of November 2021 until early February 2022. We are pleased that many of our members have returned.

A significant development during the year was the adoption of the use of the new name of CraftAbility. This is registered with the Charity Commission as a working title. This change has been very well received by funders, members and the local community and we hope it will encourage more new members.

The Trustees continue to place emphasis on raising revenue from local charities, grant providers and donors. We remain very appreciative of the support of donors, funders and individuals, particularly where this has continued in these uncertain times. It is hoped we can hold more fundraising activities in the coming year.

The members and Trustees are also very grateful for the service provided by Uttlesford Community Travel in transporting members back and forth and to Bentens in examining the annual accounts.

We also remain indebted to Judy Weavers (Centre Manager) and her team who have done so much to adapt to the problems presented by COVID lockdowns and to ensure that the Centre re-opened in a safe way.

Future Developments

We are hopeful that 2022/23 will see a return to normal operations. The Trustees are mindful that there will be challenges ahead, particularly as costs soar with increasing energy prices. It will also be challenging to maintain funding levels in a more difficult economic environment.
