P&T 235-23	Apologies for absence Apologies were received and accepted from Cllrs de Vries and Gregory.
P&T 236-23	Declarations of Interest Cllr Freeman declared a generic non-pecuniary interest as a member of Uttlesford District Council (UDC) and Cllr Gadd declared a generic non-pecuniary interest as a member of Essex County Council (ECC).

Road names will be suggested to UDC who will make the decision in line with their Street Naming Policy and in consultation with Royal Mail. This would be in memory of Kitty Wilson, a former Mayor and resident of Saffron Walden, who fostered over 200 children in her lifetime. 2. Cardiff Close / Court This is in memory of Jack Cardiff, an Oscar winning cinematographer who lived in Saffron Walden. 3. Eder Street / Road This is to honour our twin town Bad Wildungen, in Germany. The river Eder runs through Bad Wildungen. Alternatively, Armsfeld Avenue (Armsfeld being part of Bad Wildungen).
