	The Chair explained that this application has been submitted directly to the Planning Inspector and our response will be sent directly to PINs, not via UDC.
	It was noted that UDC considered their statutory response this week and the officers report requires some amendments and updates regarding the Neighbourhood Plan which will reach referendum this year. This was raised during the UDC meeting an an amended report should be submitted to PINS.
	Resolved: Committee resolved to oppose to the following factors: Loss of sports field sports facilities and open space. Should the application be approved suitable mitigation measures must be implemented via the S106. The loss of these facilities is contrary to the Local Plan policy LC1, detailing "Development will not be permitted if it would involve the loss of sports fields or other open space for recreation, including allotments. Exceptions may be permitted if either of the following applies: a) Replacement facilities will be provided that better meet local recreational needs" Therefore, the facilities should be replaced.
	Concerns include: There is not an affordable housing provision and suitable conditions should be implemented to protect the site, which sits in a conservation area.
