Therefore, it was agreed to suggest road names could relate to Edwin Smith an artist who, in his later life drew architectural plans for properties in Saffron Walden. And Olive Cook a local historian who lived in Saffron
	Walden and was married to Edwin Smith. Suggested names being Olive Cook Gardens and Edwin Smith Close.
