	Uttlesford District Council has launched an online consultation (found online at https://uttlesford-consult.objective.co.uk/kse/event/37222) regarding their draft Developer Contributions, Supplementary Planning Document (SPD) for Uttlesford.
	UDC has noted the following: The new SPD would be used to inform planning applications to ensure the right amount and type of infrastructure is provided where it is needed across the district.
	This SPD provides advice on developer contributions, including the: negotiation of Section 106 agreements, charges for monitoring of obligations, detailed considerations on a range of infrastructure such as affordable housing, biodiversity, community facilities, education and school transport, flood and water management, healthcare, landscaping and open space, and sports facilities.

It is intended for use by developers of residential schemes and the council will aid the consistent application of policies. A key aim is to assist developers in making planning applications (particularly during pre-application negotiations) and to minimise planning delay and uncertainty. It is recommended that SWTC respond to the consultation and delegate the response to the Town Clerk, Lisa Courtney and Committee Clerk, Georgia Arnold. The response will be in line with SWTC's adopted policy on developer contributions, S106 wish list and planning engagement.
