8	<b>Byrd Gardens</b> - Gordon Percival Septimus Jacob was a composer who lived his later life in Saffron Walden. Gordon's list of work exceeds more than 700 and in 1968 he was appointed CBE. Byrd is a reference to Gordons first successful work during his student years "William Byrd Suit
	<b>Ferry Gardens</b> - Edward Bawden lived his later life in Saffron Walden, Edward was a painter known for his contributions as a war artist during World War II along with prints, book covers, posters, and garden metal furniture. Edward was honoured with a CBE and taught the Royal College of Art. "Ferry Across the River" is one of his most recognisable pieces of art, highlighted most recently at London Underground station Tottenham Hale.
