	Chief Inspector Martin Richards and local officer PC Ryan McNamara provided a verbal update on the policing team in Saffron Walden noting the following:
	 Essex Police is reverting back to the Town Team format, looking to recruit new officers.
	 The communication strategy is being reviewed and regular meetings are taking place with Uttlesford District Council.
	 The three priorities are violence, anti-social behaviour and road safety. Essex Police is looking to host a community event in August 2023.
	Questions surrounding county lines work were raised and Essex Police explained this intervention work will be carried out with the Community Safety Partnership.

	Councillors raised some questions around addressing lower-level crimes before it escalates, and Essex Police explained they are looking into running more school projects around intervention and support work with youths.
	Council passed on their thanks to Chief Inspector Martin Richards and PC Ryan McNamara for their update.
