8	<p>Heritage Development Group 1647 Memorial Sculpture Project</p> <p>The HDG is considering installing a memorial sculpture to commemorate the 1647 democratic debates. At time of writing this agenda the HDG is still determining whether to proceed with the project, should the group agree to the project, council is asked if it supports the project in principle or not. Attached is an image of the proposed sculpture.</p>

This draft response will then be presented along with a proposed response to the Full Council meeting on 13th November 2023.</p>
11	<p>Essex County Council Draft Waste Strategy</p> <p>ECC has prepared a draft waste strategy which is currently open for consultation closing 22 November 2023, details found here: https://www.essex.gov.uk/wastestrategy</p> <p>Council is recommended to appoint a small working group to respond to the survey outside this meeting with officers.</p>

12	<p>Community Governance Review of Parishes</p> <p>SWTC and Swards End Parish Council jointly requested Uttlesford District Council to initiate a community governance review. The review requested that the land known as north Shire Hill, currently sitting in the parish of Swards End, is transferred to the Saffron Walden Town Council parished area. This land forms part of the planning application UTT/21/2509/OP and Council had previously and formally agreed to this boundary change.</p> <p>UDC has begun this review and opened the public consultation regarding the proposal which closes 13 November.</p> <p>Council is recommended to respond to the consultation in support of the proposal, aligning with the original request from SWTC and Swards End Parish Council to amend the boundary.</p>
13	<p>Uttlesford District Council budget 2024/25</p> <p>UDC has invited residents, town and parish councils to take part in this year's consultation on UDC's spending priorities for 2024/25.</p> <p>It is recommended a working group including the Mayor, Leader and officers to respond outside this meeting; Council may wish to provide some general guidance to any proposed response.</p> <p>The consultation can be found at https://letstalk.uttlesford.gov.uk/uttlesford-district-council-budget-2024-25 closing Sunday 5 November 2023.</p>
14	<p>Local Government Association and National Association Local Council's Corporate Peer Challenge</p> <p>The LGA and NALC offer the opportunity for large councils to be chosen for a corporate peer review.</p> <p>The LGA and NALC offer this free service for five selected councils annually, further details on the review process and how it is undertaken is attached.</p> <p>Council is asked to consider whether officers should pursue this further, requesting that SWTC is considered under this review programme.</p>
15	<p>Equipment Purchase and Disposal</p> <p>Council is asked to note the following for information only, regarding the purchase of a Toro LTF3000 4WD Heavy duty flail mower from Reesink Turfcare.</p> <p>The purchase has been funded from Vehicle Plant & Equipment Replacement Ear Marked Reserve (9140). The net cost is £50,925.44.</p> <p>The Council sold redundant equipment for £23,300. This has been returned to Vehicle Plant & Equipment Replacement Ear Marked Reserve (9140) and is being used to offset the cost of the Toro. The balance remaining in Ear Marked Reserve (9140) is £41,881.</p>

UDC is seeking comments on its suitability and accessibility.
