Summary

Organisations can nominate an asset to be included within the local list of ACV's.

As described on the Uttlesford District Council website¹:

"A building or piece of land is an asset of community value if it is at least partly within Uttlesford district and its main use has recently been to further the social wellbeing or social interest of the local community and it could do so in the future.

If land or buildings on the list come up for sale in the future, then the local community has a period of six months to raise funds and prepare a bid to buy the asset."

UDC has reviewed the ACV procedure and made changes to make it more robust, detailed in the attached Cabinet report for information. Notably reference 14.3 in the cabinet report states:

"In the case that the land is already owned by the UDC, a parish council or community group, advise to seek other legal mechanisms to protect the land. Nominations of this nature without a clear rationale for why they should be listed, given the land is owned or leased by the Council or nominating body, will be moved straight to the List of Assets not listed, and the nominating body will be informed."

The above ACV's therefore do not all require a new application form as some of the assets are owned by UDC/SWTC/Essex County Council (ECC).

Recommendation

To re-apply for ACV status for the assets **that are not** in the ownership or management of a council, this is following the guidance of UDC's revised ACV procedure. The assets in private ownership should be re-applied for ACV status.

Should Committee wish to request other assets for ACV nomination they should be agreed at this meeting.
