	The Clerk completed the CiLCA course in 2011, further completing the GPC element in 2017. Saffron Walden Town Council is therefore eligible to adopt the General Power of Competence and must do so at the first meeting of Council following elections.
	Council is requested to adopt the General Power of Competence with immediate effect.
