P&T 353-23	Declarations of Interest Cllr Freeman declared a generic non-pecuniary interest as a member of Uttlesford District Council (UDC) Cllr Gadd declared a generic non-pecuniary interest as a member of Essex County Council (ECC). P&T 357-23	Harvey Way Priority Signage Committee noted drivers at Harvey Way often struggle to drive up or down the road due to the narrow bend and parked cars, noting installation of priority signage would be beneficial to relive drivers from having to reverse up or down the hill. Committee noted this issue has been brought to the attention of members from residents. Committee agreed to submit a Local Highway Panel request to instal priority signage.
