Standing item: Committee to receive an update from the County Councillor
Harvey Way – Priority Signage Drivers at Harvey Way (off Ashdon Road, Saffron Walden) often struggle to drive up or down the road due to the narrow bend and parked cars. It has been suggested a vehicle priority sign is installed to relieve drivers from having to reverse up or down the hill so the priority of incoming traffic is understood. Committee is asked whether it supports this request from residents and if so to submit a Local Highway Panel Request to install the signage.
